ASES Agreements 2023-2024

General Information

- ASES begins the first day of school, Monday, August 21st, 2023 and runs through Thursday, June 6, 2024.
- Spots will not be held for No Call / No Shows on the first day of school.
- The ASES program operates every school day and is closed on school holidays.
- ASES begins immediately after school and runs until 6:00 PM daily.
- Flyers are sent home with students to advertise re-enrollment procedures and dates for the program. Information is posted at each campus in the after school classrooms.
- Although applications are accepted at any time during the school year, most programs fill to capacity in the morning on the first day of school.

Enrollment Guidelines/ Waiting List

- Students are admitted on a first come/ first served basis.
- When the program reaches capacity a waiting list will be created. Students wishing to attend the program will be added to the list. As openings occur, students will be added from the waiting list. On the first day of school, numbered waiting list forms will be available.
- Parents were notified of their student's enrollment status for the 2023- 2024 school year before the end of the 2022 - 2023 school year.
- Students removed from the program for poor attendance or behavior may be added to the waiting list.
- Students must have a completed application form (signed by parent/guardian) on file before they will be enrolled.

Attendance

Funding for the ASES program is dependent upon student attendance. In order to keep after school grant funding it is important that all students have good attendance.

All students are expected to:

- Check-in and participate in all after school courses they are enrolled in
- maintain a 90% cumulative attendance rate
- arrive on time— program starts immediately after the regular day ends
- **comply with the 6 PM closing time**
- We recommend parents notify ASES when their student will be absent for an extended amount of time.
- Students must attend the regular school day in order to attend the ASES program. If your student was checked out of school and returned to ASES from an appointment, program staff must be notified by the adult dropping off the student.
- If attendance requirements are not met, student may be removed from the program.
- Parents may request a copy of their student's after school attendance at any time by contacting the Site Facilitator in advance.

Early Release Policy

Students are required to follow the policies outlined in the Early Release Policy. The Early Release Policy is posted and available at student sign out. The after school grant requires justification if students leave **before 5:50 pm**. This is not a drop-in program. Students that repeatedly leave at the beginning or during program will not meet attendance requirements. Students participating in after-school sports must report to ASES and sign in before going to practice / game. We need a copy of an official document from the agency if a parallel program is attended.

Pick-Up / Sign Out

- **PARENT PICK UP**— It is the responsibility of the parent or guardian to ensure their child is picked up between **5:50 pm-6:00 pm daily**. **STUDENTS PICKED UP AFTER 6:00 PM are subject to a late fee and POSSIBLE REMOVAL FROM THE PROGRAM**
- **BUS RIDERS** must comply with all bus rules. If a student is disruptive on the after school bus they may be removed from the ASES program. If students miss the after school bus, a parent/guardian must be able to pick the student up.
- **WALKERS**— For the safety of all (7th and 8th) grade students, walking students are required to sign out, leave campus and head directly home. Students that walk home will be released 15 minutes prior to dark during the winter months.
- **ALL STUDENTS**— **must be signed out of the program daily by an adult 18yrs or older**. ASES allows for only 7th and 8th grade students walking or parents to sign out.

Illness/Injuries/Emergencies

Your student's health and safety are first priority. The parent or guardian will be notified of illness or injury. If parent or guardian cannot be reached, emergency contacts listed on the enrollment form will be called. In the case of a serious emergency, major injury or illness, school personnel may call for emergency services.

Behavior

- Students are expected to follow all rules and participate in activities. Behaviors warranting disciplinary action include, but are not limited to, any act that is harmful or hinders cooperative play or activities.
- All regular school rules apply during the ASES After School Program at each location—**no cellphones usage during ASES Program**.
- Students may be sent home early for disruptive behavior; a parent or guardian must be prepared to pick students up early if necessary.
- Behavior that would result in a school suspension warrants removal from the after school program.
- Participation is a privilege. Any student may be removed from the program for inappropriate or disruptive behavior.
- Items that are not allowed at school are not allowed in the ASES Program.
- Parent conduct: For the safety of all students and staff, parents are expected to practice appropriate verbal and physical conduct while at the school site. Inappropriate conduct from a parent may lead to their child being terminated from the ASES program immediately.
